President's Report

PERC President and CEO Roy Willis discussed next steps after the passage of the Propane Education and Research Enhancement Act of 2014. Results of the new price analysis are expected from the Commerce Department soon.

Mr. Willis said that the new law amends the Propane Education and Research Act of 1996 to direct PERC to develop training programs on strategies to mitigate negative effects of future propane price spikes for propane distributors and consumers.
